**INTERVIEW REPRODUCTION ORDER**

**NOTICE: WARNING CONCERNING COPYRIGHT RESTRICTIONS**

**Sharing Policies and Charges for Oral History Interviews**

**A. Electronic Copies.** You may request up to five individual interviews in MP3 or MOV format. These files would be delivered via a link to cloud storage (an electronic folder in OneDrive) that is maintained by the City of Boulder. To receive electronic files, you would need to provide a secure email address, and you would be responsible for downloading the files within one week of their placement in OneDrive. **No cost is associated with the transfer of electronic copies.**

**B. Physical Media for Copies.** In lieu of electronic transfer, you may choose to receive CDs/DVDs for up to five requested interviews. Prices for copies reflect the cost of media, staff time, and wear and tear on our equipment.

- **\$10 per audio CD** (interviews are supplied in mp3 format; most interviews can be placed on one CD)
- **\$10 per DVD** (one interview per DVD; no more than 2 hrs. of interview fit on one DVD)
